# Innovative hydrogel "mediNiK®" from Purenum GmbH receives CE mark

# Milestone achievement for medtech start-up in Bremen on the way to marketing an innovation for kidney stone patients

Bremen, 19 July 2021 - Purenum GmbH, a start-up specializing in innovative medical hydrogels and adhesives, announced the successful CE certification of its first product development. The quality management system required for medical products in accordance with the international ISO standard 13485:2016 was already audited and certified by TÜV Nord CERT GmbH in July 2020. The first surveillance audit could already be successfully completed "on its own feet" this year.

In the European Union, a CE mark is required for the marketing of a medical device which certifies the compliance with all relevant standards and laws.

The spin-off of the Fraunhofer IFAM in Bremen was supported by Activoris Medizintechnik GmbH for certification of the quality management system and in the implementation of the conformity assessment procedure. Also, Activoris initially provided the quality management representative as a service.

Manfred Peschka, CEO of Purenum GmbH commented: "The CE marking of our hydrogel "mediNiK®" in combination with the establishment of a quality management system is an important milestone in our still young company development. We have now created the know-how and defined the processes to successfully bring further innovations through the necessary approval processes."

Many millions of people worldwide suffer from kidney stones, mostly to be removed by surgical/endoscopic procedures. However, residual stones may remain after treatment. For example, because they are too small to grasp or difficult to access in the renal calices. If these do not come off naturally, they remain in the kidney.





With "mediNiK®, Purenum is developing a medical adhesive for the removal of kidney stone fragments to remove these residual stones. The mediNiK system consists of a biological hydrogel which embeds the residual stones in a matter of seconds and thus makes them removable by means of gripping methods used in the flexible URS.
